1. Lot no. 1: Three (3) Tractors with Trailer and Slasher

1.1 Carpenter Motors Vanuatu Ltd - Bid was NOT Responsive for reasons:

- Do not comply with the required Specifications as only 3 cylinders;
- Trailer and slasher not included;
- No documentary evidence provided on financial capacity, experience and technical capacity, suitability for use in local conditions.

1.2 Motor Traders Ltd - Bid was Not Responsive and reasons:

- Trailer and slasher not included;
- No documentary evidence provided on financial capacity, experience and technical capacity, suitability for use in local conditions.

2. Lot no. 2: One (1) Grader

2.1 Motor Traders Ltd - Bid was Not Responsive and reasons:

- The proposed grader does not meet most of the requirements;
- The proposed grader is too small with insufficient power and weight;
- No documentary evidence provided on financial capacity, experience and technical capacity, suitability for use in local conditions.

2.2 Intra Pacific Trading Co. Ltd - Bid was Not Responsive and reasons:

- Specifications related to engine and transmission are not met;
- Rear ripper is optional when should be provided;
- No documentary evidence provided on financial capacity, experience and technical capacity, suitability for use in local conditions.

2.3 Earthquip Ltd - Bid was Not Responsive and reasons:

- Specifications related to engine and power is not met.

2.4 Carpenter Motors Vanuatu Ltd - Bid was Not Responsive and reasons:

- Specifications do not include ripper and scarifier;
- Weight is lower and than specified;
- No documentary evidence provided on financial capacity, experience and technical capacity, suitability for use in local conditions.

3. Lot no. 3: One (1) Prime Mover

3.1 Carpenter Motors Vanuatu Ltd - Bid was Not Responsive and reasons:

- Do not comply with the required Specifications as no trailer with truck as specified;
- No documentary evidence provided on financial capacity, experience and technical capacity, suitability for use in local conditions.

4. Lot no. 4: One (1) Loader - Nil

5. Lot no. 5: One (1) Rubber Tire Roller

5.1 Earthquip Ltd - Bid was Not Responsive and reasons:

- The proposed roller is too small with insufficient power and weight;
- The proposed roller has only 4 cylinders.

5.2 Intra Pacific Trading Co. Ltd - Bid was Not Responsive and reasons:

- Very little information provided;
- The proposed roller is under weight;

- No documentary evidence provided on financial capacity, experience and technical capacity, suitability for use in local conditions.

5.3 Motor Traders Ltd - Bid was Not Responsive and reasons:

- The proposed roller is too small with insufficient power and weight;
- The proposed roller has only 4 cylinders instead of 6.
- No documentary evidence provided on financial capacity, experience and technical capacity, suitability for use in local conditions.

5.4 Bodiam Engineering Ltd - Bid was Not Responsive and reasons:

- Insufficient information provided;
- R.O.P.S. not specified and 4 cylinders specified and not 6;
- Cabin features not met.

5.5 Carpenter Motors Vanuatu Ltd - Bid was Not Responsive and reasons:

- Insufficient information provided;
- R.O.P.S. not specified and 4 cylinders specified and not 6;
- No documentary evidence provided on financial capacity, experience and technical capacity, suitability for use in local conditions.

8. Lot no. 8: One (1) Water Tank Truck

8.1 Earthquip Ltd - Not Responsive and reasons:

- No specifications or details provided;
- No documentary evidence provided on financial capacity, experience and technical capacity, suitability for use in local conditions.
