#### **PROCEEDINGS**

The Meeting was called to order at 2:00pm by the Chairman of MCA-Vanuatu Steering Committee.

## Welcome by Chairman

Chairman welcomed all and outlined the Agenda Items for discussions as detailed below.

### **Agenda Item:**

- 1. Public Works Department (PWD) Compact Obligation
- 2. Steering Committee Response to MCC's Response to the Disbursement Request Package (DRP):
- 3. AOB
- 4. Date for next SC Meeting

The Agenda was adopted.

## 1. Public Works Department (PWD) Compact Obligations:

- a. The SC resumed their June discussions of PWD's issues in meeting compact obligations. Both the Ministry of Infrastructure and the PWD representatives on the Steering Committee (SC) were in attendance. PWD's role in guaranteeing the sustainability of the roads and the investment in them was reviewed. A paper jointly developed by MCA-V and MCC-V: "Towards a MCA-V and MCC Position on the Role of PWD in the Vanuatu Compact" was used as the basis of discussion. A summary table from this paper is reproduced as an attachment to these minutes.
- b. DG MIPU advised that the compact had been a big learning experience and a great challenge.
- c. Program Director, MCA-V noted increased support from Allen Faerua as Director of PWD.
- d. There was a detailed discussion of PWD's 2008/ 2009 reports and plans against the compact and Service Performance Agreement (SPA) requirements and the areas of weakness were identified. Director Faerua admitted that there was a work culture problem at PWD. He hoped that the new AusAID-funded Vanuatu Transport Sector Support Program (VTSSP) might be able to assist with a longer-term approach.
- e. Allen reported on community consultations to explain the concept of community road maintenance contracts. He noted that AusAID liked the community contract concept required by the compact and were providing assistance to build on these.

- f. Allen noted that the SANMA PWD (using new equipment provided under the compact) had set a record to maintain 1 km of road per day to trafficable standards so that Section A could be handed to the road contractor for the commencement of the Santo road-works.
- g. A follow-up meeting between MCA-V, MCC-V and PWD was scheduled for July 7, 2009 to discuss progress with filling PWD vacancies; outsourcing options; use of the Government's 2009 road maintenance allocation; and PWD arrangements and support to the Santo East Coast Road project.

# 2. <u>Steering Committee Response to MCC's Response to the Disbursement Request Package (DRP):</u>

The SC discussed MCC's response to the DRP, and noted MCC's concerns to ensure disbursement targets are met and road-works continue to be fast-tracked. It was noted that a meeting was scheduled with the Independent Engineer for July 7, to discuss concerns with the contractor's schedule.

Acting Director DESP stated that he was confident that the road-works would make a major difference, boost the economy and attract more investors.
