• PWD ESU Staff – PD MCA-V confirmed that MCA-V will take up contractual issues with PWD and ensure that staff contracts are amended to allow staff benefits to match up with the rate the MCA Program staffs is currently on.

## 2. <u>Ceremony to Celebrate Road Construction Progress.</u>

The SC was presented with the planned program activity for the ceremonies to mark the occasion of the road construction progress particularly for the sections of road that have been completed on the Efate Ring Road and Santo East Coast Road. It included the 3 sections on the ERR and section A on SECR and the ceremony will also mark the first visit of the US Ambassador to Vanuatu based in PNG, the Hon. Teddy Taylor. Invitations were prepared by the Vanuatu Government and were forwarded to all development partners to participate at the occasion.

Press-releases and speeches were also prepared and forwarded to all media outlets for public information to attract wider participation from beneficiaries, citizens and residents on the two islands of Efate and Santo.

According to the planned program there will be two ceremonies on the two project sites at Lopelope on Santo on  $3^{rd}$  February 2010 and at Takara on  $4^{th}$  February on Efate.

Logistical arrangements were also in place following meetings with the two Provincial Governments of Sanma and Shefa and funds allocated for the ceremony is to be shared in the following order:

• Vanuatu Government contribution to include Chartered aircraft VT 2,700,000

•	MCA-V contribution	VT 2,000,000
